CSR-Indian Institute of Integrative Medicine (IIIM) has rich legacy of natural product research. The institute was established way back in 1941 having two wings viz Research and Production. In 1957, Council of Scientific & Industrial Research (CSIR) of Govt. of India took over the research wing and renamed as Regional Research Laboratory, Jammu. Given its core strength in natural products-based drug discovery, the Institute redefined its mandate in 2005, and renamed as Indian Institute of Integrative Medicine (IIIM). Today, CSIR-IIIM, Jammu, has state-of-the-art facilities to discover new drugs and therapeutics for mankind (<https://iiim.res.in>). The current mandate of IIIM is to be an internationally renowned center of excellence in all facets of natural products research and technology.



Society for Ethnopharmacology (SFE), India

Society for Ethnopharmacology (SFE) is registered under the West Bengal Society Registration Act and also affiliated to the International Society for Ethnopharmacology (ISE). It was formed in the year 2013 and has made its broad presence throughout the country through different local chapters in different part of the country. The main mission of the society is promotion and development of Ethnopharmacology, medicinal plants, traditional medicines and other natural products through dissemination of information for globalizing local knowledge and localizing global technologies. Ethnopharmacology involves a wide range of scientists with varying specialties. The practices and public interest in natural therapies, namely herbal medicine, have been increased dramatically throughout the world. This has increased the international trade in herbal medicine enormously. A paradigm shift is observed in the use of natural product-based medicine for the management of health care, which can significantly impart a major task in economic growth. About the Conference

This important addition of new category has provided a ray of hope for innovations and development of new drugs from botanicals in a scientific way and it would help in the global acceptance of the use of plant-based products.

This international congress will comprise wide range of important scientific sessions including Keynote presentations, Plenary talks, Special sessions and Oral/Poster sessions by the renowned International and National scientists and subject experts focused on several crucial and contemporary issues on the scientific study on traditional medicine based on the medicinal plants and Ethnopharmacology.
