The fellows will be elected on the basis of distinguished contributions to the following subject areas:

- Ethnopharmacology and Ethnomedicine;
- Photochemistry and Pharmacognosy; Natural Products/ Nutraceuticals/ Phytopharmaceuticals
- Documentation, conservation and promotion of Traditional Knowledge, Traditional healers
- Ayurveda, Unani, Siddha, and Homeopathy and persons working in the area of medicinal plants/traditional medicine, and philanthropists
- Any other persons working in the area of medicinal plants/traditional medicine, and philanthropists

### **Who can nominate**

Candidates may be nominated by (i) Vice-chancellor of the Universities, (ii) Director/ Head of the Institutes /Organizations/ Industry. (iii) The Executive Committee Members of the Society for Ethnopharmacology & International Society for Ethnopharmacology (iv) Fellows of the national academies and past Fellows of SFE India.

### **Fellows of the SFE will have:**

- A Certificate of appreciation, Citation and a Memento
- Recognition at SFE Annual Convention
- Lecture in the field of specialization during SFE Convention.

### **Criteria**

- The nominee should have at least 10 years of experience in their field.
- Nominee can be re-nominated after a gap of 2 years. Nominations remain valid for five years unless the proposer or seconder withdraws it before election.
- Preference will be given for the member of Society for Ethnopharmacology, India

- Last date to receive the completed nomination – September 30, 2026
- Announcement of shortlisted candidates - October 01, 2026
